### 1. Health & Vaccinations

### 3. Behavioral Responsibility

### 4. Belongings

### 5. Parasites

If my pet is found to have fleas, ticks, or other parasites, I authorize treatment at my expense.

### 6. Food & Feeding

I agree to provide feeding instructions and enough food for the duration of my pets stay. If none are provided, the resort may feed house food. I understand dietary changes may cause stomach upset.

### 7. Emergency Situations

In emergencies such as natural disasters or fire, the resort will take reasonable protective measures but cannot guarantee outcomes. I release them from liability for events beyond their control.

#### 8. Abandonment Clause

If I fail to pick up my pet within 72 hours of the scheduled pickup date and do not make arrangements, the pet may be considered abandoned under Alabama law, and necessary action may be taken. I remain responsible for all charges.

#### 9. Liability Release

I release the resort, staff, county, and affiliates from liability for injury, illness, escape, or death except in cases of proven negligence.
